Call for health and social care staff to contact their host NHS employer for a COVID-19 jab

The NHS vaccination programme, the biggest in health service history, is off to a strong start with millions of people having been vaccinated across the country thanks to the tireless efforts of many colleagues. A huge number of health and social care staff have already been vaccinated, but those members of staff (including those working for sub-contracted providers) yet to receive their vaccine are <u>now asked to speak to their host NHS employer</u> about arranging their jab which is safe, simple and offers crucial protection against the virus.

Guidance for clinically extremely vulnerable staff

NHS Employers is receiving an increasing number of queries over the position of clinically extremely vulnerable staff after they have been vaccinated. To clarify - Government <u>guidance</u> states that even if clinically vulnerable staff have received both doses of the COVID-19 vaccine, they should continue to follow shielding advice, which includes advice relating to working arrangements.
